



NEW AGENCY TO PROMOTE INVESTMENT AND EXPORTS

Decree no. 60/2016 12 December was published recently and will come into force 180 days after its publication (i.e., 11 June 2017). The aim of this new Decree is to create a single entity that will bring together all actions to promote public and private investment, and exports. The objective in creating this entity is to bring greater dynamism to the business environment, to optimise resources and to create greater synergies in these areas of great importance and impact for the economy of Mozambique.

With the creation of the Agency to Promote Investment and Exports (Agência para a Promoção de Investimento e Exportações - APIEX), the CPI (Centre for Promotion of Investments), GAZEDA (the Office of Accelerated Development Economic Zones) and IPEX (Institute for the Promotion of Exports) will be dissolved. The rights and obligations and the financial resources and assets of these dissolved bodies will be transferred to APIEX.

As a consequence, APIEX will have the following role:

- i) To develop and implement actions aimed at guaranteeing the promotion and management of processes to carry out public or private investments, made by Mozambican or foreign entities;
- ii) To create, develop and manage the Special Economic Zones (Zonas Económicas Especiais -ZEEs) and the Free Industrial Zones (Zonas Francas Industriais - ZFIs);
- iii) To promote Mozambican exports.

Besides establishing the role of APIEX, the new Decree establishes its powers, its headquarters and management, the supervisory body and the sources of revenue and assets allocated the agency. The organic statute of APIEX and the respective legal instruments have not yet been approved. However, this should occur within 60 days of the date of publication of the Decree.
