# PRESIDENTIAL DECREE NO. 198/14 - PRESIDENT OF THE REPUBLIC

DIÁRIO DA REPÚBLICA SERIES I NO. 147, OF 12 AUGUST 2014

**Summary:** Amends articles 10 and 13 of Presidential Decree no. 62/11, of 18 April, which establishes the Bases and the Administrative Organisation Framework of the City of Kilamba, and delegates power to the Minister of the Territorial Administration, of Public Administration, Employment and Social Security and Finances, to approve and publish by Executive Decree, the staff of the Administration of the City of Kilamba. Repeals nos. 3 and 4 of article 11 of Presidential Decree no. 62/11, of 18 April.
