**Summary:** Authorises the incorporation of the insurance company Prefira Seguros, S.A.

## PRESIDENTIAL DISPATCH NO. 136/14 - PRESIDENT OF THE REPUBLIC

#### DIÁRIO DA REPÚBLICA SERIES I, NO. 132 OF 16 JULY 2014

**Summary:** Approves the Bridging loan, convertible into Treasury Bonds, non-readjustable as from 2015, between the Ministry of Finance, representing the Republic of Angola, and a consortium on internal banks headed by Banco Angolano de Investimentos – BAI, in the total amount of AOA (Angolan Kwanza) 150 billion, and authorises the Minister of Finance to sign the said financing and all the documentation related to the same, and he may delegate this power to other entities.

## LAW NO. 15/14 - NATIONAL ASSEMBLY

**Summary:** Law that governs the protection of copyright and connected rights, in the areas of art, literature, science and other forms of knowledge and creation. Repeals Law no. 4/90 of 10 March, and all legislation that contradicts the Law. This law must be applied in the resolution of disputes that are not final in everything to the benefit of the author.

It also fixes the value of the road and traffic supervision tax. Repeals Executive Decree no. 308/13 of 23 September.
