PRESIDENTIAL DECREE NO. 299/14 - PRESIDENT OF THE REPUBLIC

DIÁRIO DA REPÚBLICA SERIES I, NO. 198 OF 4 NOVEMBER 2014

Summary: Approves the Organic Statute of the Ministry of Finance. Repeals Presidential Decree no. 235/12 of 4 December.

RECTIFICATION NO. 20/14 - SECRETARIAT OF THE COUNCIL OF MINISTERS

DIÁRIO DA REPÚBLICA SERIES I, NO. 198 OF 4 NOVEMBER 2014

Summary: Rectifies article 20 (Staffing and Organisation Chart), of Presidential Decree no. 182/14 of 28 July, which approves the Organic Statute of the Ministry of Public Administration, Employment and Social Security, published in Diário da República no. 138, Series I.

Repeals Decree no. 24/80 of 20 March, Decree no. 29/98 of 4 September and Decree no. 33/99 of 19 November.

RESOLUTION NO. 4/14 - CONSTITUTIONAL COURT

Summary: Creates two chambers with general jurisdiction to judge ordinary appeals of unconstitutionality and to assess on the legality of the formation of coalitions of parties. Melo, Miguel Correia and Raul Carlos Vasques Araújo and the member of the second chamber is António Carlos Pinto.

JOINT EXECUTIVE DECREE NO. 361/14 - MINISTRY OF THE ECONOMY AND INDUSTRY
