





The legal tech industry is experiencing a dynamic shift with the adoption of the Artificial Intelligence Act (AIA) in Europe – among others- and the ensuing numerous compliance obligations for AI Systems. This framework, the first comprehensive AI regulation globally, aims to ensure responsible development and use of AI, with hefty fines up to 7% of turnover or 35mil euros for non-compliance, even for companies not based in Europe. 
